**TERMS AND CONDITIONS**

- Equipment rental prices apply to full days, with a minimum charge of one day's rental.
- RENTER shall be billed at least one (1) minute airtime for any incoming, outgoing or incomplete call/SMS, and is responsible for airtime charges at one minute increments during the entire period the phone is rented. Billing begins when call completes and ends by pressing **END**. Renter is also responsible for any data usage during this period.
- Airtime charges will be estimated by reading the non-reset air timer on the phone + 25% for its inaccuracy. The final bill will be sent out with actual usage and corresponding rates via e-mail or fax. This process will take 4-6 weeks from the rental return date.
- The equipment including the phone and accessories will remain the property of Triptel. During the rental period no service or part replacements are authorized without prior approval from Triptel.
- Triptel may bill RENTER, on a delayed basis, by submitting an unsigned credit card voucher on behalf of RENTER, indicating that RENTER'S signature is on contract, for payment of any additional deposits, airtime, international call, or phone repair and replacement charges.
- In the event of loss, damage, theft or disappearance of the equipment while on rental, regardless of circumstances, RENTER shall pay to Triptel on demand the amount of the replacement or repair cost of the equipment. RENTER is responsible for all airtime charges until the loss of the phone is reported in writing to Triptel.
- In the event that the RENTER loses the equipment and had accepted insurance coverage on the contract, RENTER is responsible to provide a police report, and pay the deductible amount as well as the Rental Charges and Air Time Charges to Triptel.
- Since Triptel is using many different cellular carriers, Triptel makes no warranty about quality of the cellular service, and shall not be liable for any damages in connection with use of equipment.
- This agreement cannot be transferred, or modified by RENTER except in writing by Triptel or its authorized agent.
- Triptel may charge RENTER an additional \$250 deposit for every two (2) weeks of additional rental period.
- GSM rates will be **ESTIMATED** at the highest rate and will be adjusted on the FINAL bill.
- Airtime charges WILL APPLY even if the SIM is changed.
- Renter shall be responsible for collection of attorney fees for unpaid bills.

By signing this agreement RENTER understands and accepts the rates and conditions of this agreement.
